As a first-generation Mexican American who had an opportunity to obtain a PhD in Biostatistics from Harvard, I decided to establish my career at the intersection of primary care, public health and biostatistics.

To this end, I'm currently the statistical editor for *JAMA Health Forum* where I have the opportunity to shape the dissemination of topics that I am passionate about: health policy, innovative approaches to health care delivery and health care economics, access, quality, safety, equity, and reform. I'm currently the co-chair for the NIH Community Engagement Alliance (CEAL) Needs Assessment & Evaluation Workgroup and co-publications officer for the Health Policy Statistics Section of the American Statistical Association. In 2022, I was appointed to serve on the National Advisory Committee on Racial, Ethnic and Other Populations for the Census Bureau. My contributions to primary care and community-based research were recognized by the National Academy of Medicine when they selected me in 2020 as one of only 10 Emerging Leaders in Health and Medicine Scholar and in 2022 as an elected member of the National Academy of Medicine.
